Audience Member Candice Shared her experience with trying to get a temporary housing permit with the county, and the challenges Grizzly Flats residents who lost their homes are facing when trying to get the permits to bring an RV or 5th wheel back to live on their properties. She shared that she received a document form the county with requirements that was on PFPD letterhead and wanted to know if the board was aware that there were so many requirements that had to be met, and how hard this process is for all involved. Reviewing the document will be on next board agenda

Audience member Brent shared that the permit process for a new home also requires solar, and the adjacent properties to his have not been cleared, so solar would not work until this was done. He had concerns as these were vacant lots and no homes were lost on them but the trees were still affected by the fire. He wanted to know who would be removing them and was worried what would happen if they were not removed.

Fire Marshall Earle provided information related to the fire codes and specifically water with relation to a new home or temporary housing permits.

Audience Member Julie Wynia commented on tree removal and the process, and stated that the vacant lots would most likely be the last to be cleared.
