#### **2.0 NEW BUSINESS**

2.12.1 Report from Board Committee on announcement for Fire Chief Discussion and action

Pratt – Should salary be listed on the announcement? Suggested to go without salary. Could ask them to submit salary requirements with application.

Job announcement/Job Description –

- Residency how far can they live outside the district e.g. 10, 20 30 minutes.
- Willing to reside within district boundaries within 6 months of hire.
- Six month probation if they make probation they must move to the district
- Part time position final contract to be determined in 6 months
- Take out residency requirement and discuss during negotiations
- We need to tell them up front the expectations of residency
- Listed under desired qualifications
- Chief should be part of the community
- Purpose of job announcement is a marketing recruiting piece
- Fine tuned the job description
- The job announcement and description will be separate documents
- If the job description is going to be changed the applicants should be referred to the full job description
- Remove State Fire Marshall requirements not required
- Minimum 10 years experience under desired qualifications
- Add lives within district under desired qualifications

#### Supplemental Questionnaire –

- 1. Have the applicants answer questions in writing and submit with the application
- 2. Add question what would you do to mitigate long response time. That's more of a discussion question.
- 3. Volunteer program can be done as well as volunteers in other areas of the department
- 4. The 4 questions are adequate just the beginning 4 questions
- 5. There will be a another group of questions that will be asked during interviews
- 6. The whole board cannot interview the candidates as that would be a quorum
- 7. The Chief needs to be able to get along with the crew
- 8. Add a question about recruiting experience
- 9. Add or equivalent job experience in place of degree

Pratt - We have a list of changes that we want to make

- 1. Desired Qualifications change 8 to 10 second page
- 2. Next to last sentence remove Fire Marshal reference
- 3. Remove Fire Marshall from last sentence
- 4. Add lives within the district

#### Job Announcement

- 1. Remove Money
- 2. Remove stress say Welcome you will love the community....

Dayton- We may want to contact Camino since they provide battalion chief coverage Pratt – We need to discuss as a board and set parameters around who on the board can discuss and what they can talk about.

Pratt - There are 2 sites we will post the job on. There are sites that were not used last time. There were other entities that are using the same process.

Dayton - if Fire Hire is not one of the sites it needs to be added.

Pratt – In conversations with Clive he may know someone who is interested.
